Sherry has been diligently developing her dressage skills as a young horse trainer working towards the advanced levels. Regular lessons with Vickie Argals of Flying Colours Stables are enabling Sherry to feel and see the effects of a classical seat and systematic training methods. Sherry has competed to Second Level and is working towards Third Level dressage in 2010.

Sherry is also under the instruction of Shauna Cook of Carousel Ridge Stables and is excited to develop riders over fences. Done through the use of grids and small exercises throughout the winter months then moving to course work and the finishing touches once we are able to work in the large arena in the spring. A focus will be towards an effective jumping seat and development of the horse.

Private 45 minute dressage lessons will be available in the mornings of each clinic date followed by group jumping lessons in the afternoons. Feel free to bring two or more horses or immerse your one horse in an intense clinic day!
